


## **Overview**

Eligible countries include members of the Association of Southeast Asian Nations (ASEAN): Indonesia, Malaysia, Philippines, Singapore, Thailand from GEIS and Vietnam from Frontier. Launched in 2023, the FTSE ASEAN Extended Index Series provides a comprehensive and transparent series of benchmarks for the performance of large, mid and small cap equity securities from eligible southeast Asian markets.
